I expect due diligence has been completed to link the proposed names of Burgess and Milsom to place in accordance with the current naming rules. I am respectful of the use of POW names but also recognise that this has been done many times before.

I am disappointed that Council has not shown any attempt of progression with its line of thinking insofar as gender equity or use of a traditional owners name is concerned.

The new naming rules are expected to be released this year which encourages use of female names and traditional owners names. This practice is gaining momentum within Victoria municipalities and across Australia. It would be encouraging for rural Council's to start demonstrating the same.

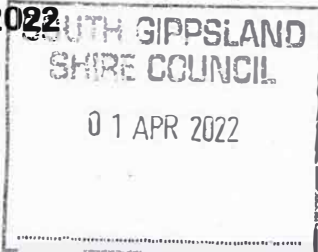

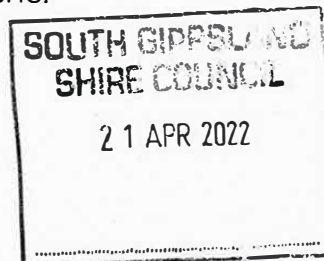

Dear Joanne,

Please find attached the survey form for the proposed road name change for part of South Gippsland Highway. I am a niece of Robert (Bob) Barguss through his wife May who was my father, Arthur Goodwill's sister.

I would dearly love to see the road named Barguss road in memory of my uncle who gave his life in service of his country on the Burma Railway in World War 2.

I understand the road ran along the side of the farm he and May owned prior to his enlistment in the Army on 26th May 1941 and became part of the 13th Australian general Hospital . He was captured in the fall of Singapore and worked on the Burma Railway till his death from Beri Beri (caused by Malnutrition) on 12 January 1944 at Tambaya Hospital, Burma. I have a copy of letter from one of his Officers in this brigade written to his wife in which he says ' all Australian ARMC (Australian Army Medical Corps) men whether trained or not had to undertake nursing duties and your husband was for some months employed in the Cholera ward at Nikki..... He did sterling work and assisted in saving a number of lives of sufferers from that dreadful disease" There are other references to the high quality of his work throughout his captivity until he could no longer work. This letter was signed by Major Bruce Hunt (13th AGH).

I earnestly request that the name "Barguss Road" be given to this section of toad as a lasting memorial to him..

Support Information for "PROSSER" as proposed name change

Harry Prosser was a stalwart and long serving Life Member of our RSL and the Koonwarra Community. He passed away on 26th October 2014 after a long illness.

Harry was born on 24th June 1922 and joined the Air Force in 1941. Service No 42672. He was posted to various points in Australia before serving in the South Pacific. He ended the war with a Sutherland Squadron working on planes like the Tiger Moth and Flying Water Planes.

He joined the R.S.L. the year he came home (1946). Initially it was with the Korumburra Sub Branch, but then in 1964 he moved to a farm in Koonwarra, so he joined Meeniyian RSL, and has been a regular ever since.

He has been the Secretary of Meeniyian for about 40 years and has served as President and Secretary of the district 41 board.

He has been awarded Life Membership of the RSL and in 2007 was awarded the highest honor, the Meritorious Medal. Harry fought to keep Meeniyian RSL going calling for help from the public and securing a new Committee. This ensured that the successful ANZAC Day Commemoration Service in Meeniyian continued.

For a long time Harry drove around the district twice a year to sell ANZAC badges and Remembrance poppies to the locals. This requires going up and down many local roads and sometimes it would take a couple of visits before he found anyone at home. Many of the locals used to look forward to seeing Harry drive up the road because they knew what it meant; badges, poppies and a chat. As a result the task could take all of the month leading up to the date.

After health problems, Daughter Bev and grandson Mark supported Harry by driving him around. There are numerous times people rejected Mark with the reasoning "I only buy from Harry" and Mark had to explain the situation and that Harry was sitting in the car. Part of the ANZAC Day and Remembrance Day campaign involves selling at the local farmers market, which is held in the Koonwarra Memorial Park where Harry and Bev shake the tin.

Koonwarra is only a small country town in a dairy farming area, so there is no big shopping area to sit. Farmers are busy on their properties, so Harry decided to visit them instead.

Even when friends have moved to other towns Harry and his wife Marge will visit to pass on badges and poppies.

When age has slowed him down a little, he had a group of friends to drive up a couple of the roads and visit other areas.

Harry was 92 when he passed away and he always lived the RSL motto: SERVING STILL

Meeniyian RSL believes that "PROSSER" is an appropriate name and would acknowledge the years of service to Town & Country by Harry Prosser

Re: Proposed Road Name Change - Part of South Gippsland Highway, Koonwarra

Too few commemorations of women's sacrifices and achievements exist in our public places, celebrating and making them visible. The ***naming of roads and streets*** is one way we can help change this, making ***women and their stories visible, public and as numerous and important as men.***

The current state of ***underrepresentation in our public place commemorations requires ongoing and longer-term attention from all levels of government*** to address the historic gap and to create a new equitable approach.

We wish to draw to your attention to the recent promotion of the Proposed Road Name Change, Part of South Gippsland Highway, Koonwarra Survey that puts forth the name of two men for consideration. Whilst there is a space to nominate another person or name, ***the practice of allowing an unrepresentative short list is discriminatory and reliant on volunteers.*** Where women make up 50 per cent of the population it is unthinkable not to understand and thus acknowledge the work of women in our public places.

We write as the founders of the Put Her Name On It Campaign and public place commemoration representation advocates to request you reconsider the nominations for the above renaming initiative and ***present a representative short list.*** We also request that going forward South Gippsland Council always ensures a representative shortlist including ***requesting this from any third party involved*** eg. Historical Societies.

We are aware of some incredible women from the South Gippsland area including Sister Rosetta Wight, Olive Francis Ketels, Geraldine Wogan Brown, Mrs Maher, Margaret Clement to name a few, that can be considered for place naming and commemoration but what we are really seeking is systemic change that will be sustained over the long term. For us to continue to put women's names forward will not change the system, will continue to burden volunteers and possibly have the same negative gender impact as today.

Therefore, to address the historic gap through systems change we again request South Gippsland Council undertake our **5 step approach**:

- 👉 Audit place names and commemorations for gender and other disaggregated data required under the **Gender equality Act** – First Nations, cultural diversity, disability, LGBTIQ+.
- 👉 Acknowledge the gender-gap.
- 👉 Amend policies.
- 👉 Accumulate a list of notable local women and their stories.
- 👉 Act to ensure gender balance in place names and commemorations.

A good way to move this forward is to **allocate a budget in the upcoming 2022/23** budget process.

We also look forward to promoting this project as a positive contribution to public place commemorative equality.

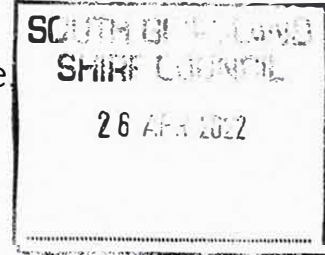
