Hi Lincon,

Thank you for the naming proposals and all the information provided.
As per the 'Geographic Place Names Guidelines 2010' & the revised draft guidelines May 2016 – 'Naming rules for places in Victoria - Statutory requirements for naming roads, features and localities':

As per the below Principle (H), road names should only use the **surname** of a person, not first or given names. bearing this in mind Council would not approve the following names;

- **Jack Rayson Drive** – the surname would be accepted.
- **Sadies Way** - As Council already has a road named Foley Road, even using the surname would not be accepted.
- **Lennie Lane** – As Council already has a road named Gwyther Siding Road, even using the surname would not be accepted.

The following principle should be adhered to:

Principle (H) Using commemorative names

Naming often commemorates an event, person or place. Examples include recognising Aboriginal people or cultural events, or following a theme such as Australian war contributions (refer to [Section 2.3 Anzac commemorative naming project](#)). When considering a commemorative name, the following points must be considered.

- *Commemorative names of people should be people held in strong regard by the community. When deciding on the assignment of a commemorative name, naming authorities should consider the person's achievements, relevant history and association to the area, and the significance of the family/person to the area/land. For example, a family that has been associated with an area for*

at least 50 years.

- The names of people who are still alive must be avoided because community attitudes and opinions can change over time.
 - A commemorative name applied to a locality or road should use only the surname of a person, not first or given names.
 - A commemorative name applied to a feature can use the first name and surname of a person; although, it is preferred that only the surname be used.
- The initials of a given name are not to be used in any instance

Please find below Vicnames results for a 15 km search on the road names as proposed for Mitchells Rise Estate stage 3 in Leongatha.

- **Luxford** – has no conflicts for any similar spelling or sounding names. Council ‘consents’ to the name as proposed “Luxford Lane”.

- **Crouch** – has 2 conflicts for any similar spelling or sounding names. Council does ‘not consent’ to the name as proposed “Crouch Court”.

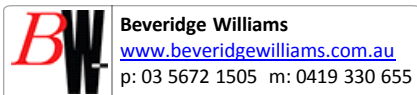

- **Sadies Way** – Refer Coast Magazine article on Sadie Foley entitled "'Oh What a Lady'" on Page 36 (https://issuu.com/coastmagazine/docs/coast_magazine_autumn_2013/36). Sadie Foley is also Percy Luxford's daughter (see below).
- **Lennie Lane** – This is an inspiring true story of nine-year-old Lennie Gwyther who, at the height of the Great Depression in 1932, rode his pony from his home town of Leongatha in rural Victoria to Sydney to witness the opening of the Sydney Harbour Bridge. Lennie's 1,000-kilometre solo journey captured the imagination of the nation, and his determination and courage provided hope to many at a difficult time in Australia's history.
